Canadian Pension Application - Instructions

Please read this *Canadian Pension Application* carefully. Be sure to answer all questions and attach additional sheets if more space is needed.

Upon the completion of processing your application, if you are eligible for benefits, you will receive a determination letter and benefit election form which will indicate the amount of the respective benefit and pension options you are entitled to receive. There will be a detailed explanation of each option available and your benefit amount under each option. Upon your review of this information, you and your spouse, if any, will be asked to elect an option under which you would like your benefit paid. The types of retirement and payment options are described in your Summary Plan Description. You do not have to elect a pension option at this time.

If you are married on your retirement date, you will need the consent of your spouse to choose an option other than a form that provides lifetime benefits for your spouse or to choose a beneficiary other than your spouse.

Proof of Age Documentation

Proof of age for you and your spouse or beneficiary must be provided to the Fund office along with your application. The acceptable types of documentation are listed below <u>in order of preference</u>: (You may submit a photocopy of these documents.)

- A birth certificate
- A baptismal certificate or statement as to the date shown by a church record, certified by the custodian of such record
- Notification of registration of birth in a public registry of vital statistics
- Hospital birth record, certified by the custodian of such record
- A Medicare card or Certificate of Social Insurance award, if age or birth date is shown
- A signed statement by the physician or midwife who was in attendance at birth, as to the date of birth shown on their record
- Naturalization record
- Immigration papers

If you cannot submit proof of age in accordance with the items listed above, then you must submit at least TWO of the items listed below:

- Military record
- Passport
- Driver's license
- School record, certified by the custodian of such record
- Vaccination record, certified by the custodian of such record
- An insurance policy, which shows age or date of birth
- Other evidence such as notarized signed statements from persons who have knowledge of the date of birth

SPOUSE DEFINITIONS

Alberta (Effective June 1, 2003).

"Spouse" means,

- (a) a person who, at the relevant time, was married to the Participant and had <u>not</u> been living separate and apart from the Participant for 3 or more consecutive years, or
- (b) if there is no person to whom paragraph (a) applies, a person who, immediately preceding the relevant time, had lived with the Participant in a conjugal relationship
 - (i) for a continuous period of at least 3 years, or
 - (ii) of some permanence, if there is a child of the relationship by birth or adoption.

British Columbia (Effective July 15, 1999).

"Spouse" means,

- (a) a person who at the relevant time was married to the Participant, and who, if living separate and apart from the Participant at the relevant time, did <u>not</u> live separate and apart from the Participant for longer than the 2 year period immediately preceding the relevant time, or
- (b) if paragraph (a) does not apply, a person who was living and cohabiting with the Participant in a marriage-like relationship, including a marriage-like relationship between persons of the same gender, and who had been living and cohabiting in that relationship for a period of at least 2 years immediately preceding the relevant time.

Manitoba (Effective June 30, 2004).

"Spouse" means the person who is married to the Participant.

"Common-Law Partner" means

- a person who, with the Participant, registered a common-law relationship under section 13.1 of The Vital Statistics Act, or
- (b) a person who, not being married to the Participant, cohabited with him or her in a conjugal relationship
 - for a period of at least three years, if either of them is married, or
 - (ii) for a period of at least one year, if neither of them is married.

New Brunswick (Effective June 27, 1987).

"Spouse" means either of a man and a woman who

- (a) are married to each other,
- (b) are married to each other by a marriage that is voidable and has not been avoided by a declaration of nullity,
- (c) have gone through a form of marriage with each other in good faith that is void and have cohabited within the preceding year,
- (d) not being married to each other, have cohabited
 - continuously for a period of not less than three years in a conjugal relationship in which one person has been substantially dependent upon the other for support, or
 - (ii) in a relationship of some permanence where there is a child born of whom they are the natural parents,

and have cohabited within the preceding year;

Ontario (Effective June 13, 2005).

"Spouse" means a person who is,

- (a) married to and is <u>not</u> living separate and apart from the Participant, or
- is not married to the Participant and is living together in a conjugal relationship with the Participant,
 - (i) continuously for a period of not less than 3 years, or
 - in a relationship of some permanence, if they are the natural or adoptive parents of a child, both as defined in the Family Law Act (Ontario).

Newfoundland (Effective December 13, 2001).

"Spouse" means, if the Participant does <u>not</u> have a Cohabiting Partner, a person who

- (a) is married to the Participant,
- b) is married to the Participant by a marriage that is voidable and has not been voided by a judgment of nullity, or
- (c) has gone through a form of a marriage with the Participant, in good faith, that is void and is cohabiting or has cohabited with the Participant within the preceding year.

"Cohabiting Partner", means

- (a) in relation to a Participant who has a spouse, means a person who is not the spouse of the Participant who has cohabited continuously with the Participant in a conjugal relationship for not less than 3 years, or
- (b) in relation to a Participant who does not have a spouse, means a person who has cohabited continuously with the Participant in a conjugal relationship for not less than 1 year,

and is cohabiting or has cohabited with the Participant within the preceding year;

Nova Scotia (Effective June 4, 2001).

"Spouse" means

- (a) either of a man and woman who
 - (i) are married to each other,
 - (ii) are married to each other by a marriage that is voidable and has not been annulled by a declaration of nullity, or
 - (iii) have gone through a form of marriage with each other, in good faith, that is void and are cohabiting or, if they have ceased to cohabit, have cohabited within the 12 month period immediately preceding the date of entitlement, or
- (b) if there is no person to whom paragraph (a) applies, an individual who has registered a domestic-partner declaration with the Participant under the Vital Statistics Act (Nova Scotia) which has not been terminated in accordance with such act.
- "Common-Law Partner" of a Participant means an individual who has cohabited with the Participant in a conjugal relationship for a period of at least 2 years, neither of them being a Spouse.

Quebec (Effective June 24, 2002).

"Spouse" means, the person who,

- is married to, or in a civil union, with the Participant, and is not separated from bed and board from the Participant, or
- (b) has been living in a conjugal relationship with a Participant who is neither married nor in a civil union, whether the person is of the opposite or the same sex,
 - (i) for a period of not less than 3 years, or
 - (ii) for a period of not less than 1 year if:
 - (A) at least one child is born, or to be born, of their union; or
 - (B) they have adopted, jointly, at least one child while living together in a conjugal relationship; or
 - (C) one of them has adopted at least one child who is the child of the other, while living together in a conjugal relationship.

Saskatchewan (Effective July 6, 2001).

"Spouse" means:

- (a) a person who is married to the Participant; or
- (b) if a Participant is not married, a person with whom the Participant is cohabiting as spouses at the relevant time and who has been cohabiting continuously with the Participant as his or her spouse for at least one year prior to the relevant time.
